STUDENT BEHAVIORAL AND RULES CONTRACT

Below are important rules pertaining to the Disneyland trip. Parents must review this information with their student! **If a student violates a rule that results in being sent home, parents will assume the financial responsibility of the student's return trip.**

Both parent and student are required to understand and sign this document.

1. General Rules and Responsibilities:
 - a. Students need to know and follow the rules!
 - b. Students will act respectfully at all times. Failure to do so will result in an automatic time out for no less than 1 hour.
 - c. Stealing is not an option. If a student is running low on money they should communicate with their chaperone, who will then make arrangements for additional funds. Security is very tight at Disneyland and California Adventure. If a student steals– they will be caught! If they are caught, they will be sent home immediately (at their parent's expense). In addition, the school will be placed on suspension, i.e., not invited back, for several years. The consequence of a minor incident could be very great.
2. At the Hotel:
 - a. Visiting Other Rooms: A boy **CANNOT** enter a girl's room and a girl **CANNOT** enter a boy's room. There are no exceptions. Boys should not loiter in front of girls' rooms and vice versa.
 - b. Sleeping arrangements: There are two queen beds in each student room. Kids are expected to share a bed. If a student does not want to share a bed, then they can sleep on the floor in a sleeping bag. Mattresses cannot be removed from the beds. If there are only 3 kids in a room, they may alternate so that a different person sleeps alone each night.
 - c. Lights out in the rooms means it's time to sleep! Students are to remain in their rooms after lights out. Buchser's Security and the hotels security will be checking all rooms throughout the night. Any reports made about a room will result in disciplinary action.
 - d. The telephones within the hotel room are not to be abused.
 - e. Leaving the Hotel Grounds: Students are not allowed to leave the hotel grounds without a chaperone.

3. At Disneyland and California Adventure :

- a. Students must be in groups of at least two: Students are free to enjoy the park without supervision as long as they have a buddy. If a student gets separated from their buddy they must proceed to the park meeting place immediately and rejoin their buddy or join another group. A buddy group may not consist of a boy and a girl. Students cannot leave the park without a chaperone.
- b. Boy and Girl Physical Contact: This is a school trip. Boys and girls are required to follow school rules regarding touching, hand-holding, etc. Students violating this rule will be warned and may be disciplined if they fail to heed warnings.
- c. All students and chaperones must attend all the Buchser performances required by their teacher. Students who are late to required performances may be disciplined by being benched for no less than 1 hour. Audience and performers may not leave the stage area between performances. There is not enough time to fit in one ride.
- d. Mandatory Meetings: Everyone, students and chaperones, must return to the park meeting place at mandatory check-in times. Students failing to return for a check-in or who are late will be disciplined (time-out at the bridge for no less than 1 hour).

4. Preparing for Performances and Performing:

- a. It is very important you behave well while back stage and on the stage itself. You are being watched and evaluated by the Disney staff at all times. We will not be invited back next year if the Disneyland event organizers receive a negative report.
- b. Keep track of all of the pieces of your uniform. Prepare uniform (including black shoes and socks) for all performances the night before.

5. Returning to Buchser:

- a. When we arrive at Buchser, help clean the bus. You will not be allowed to go home until all the trash has been removed from the bus.
- b. It is very important that your child attends school on Wednesday, May 13!!!!

I have read all of the above rules pertaining to the Disneyland Magic Music Days Trip **and** have reviewed them with my student. I understand that if my student violates any rules that result in an early return trip home, I will be financially responsible for the additional travel expenses incurred.
